

Socialization Of Strengthening The Pancasila Virtue Movement To UPMI Students

Abstract.

Pancasila, as the foundation of the state, plays a vital role in shaping the character of the nation. However, the practice of its values among students has begun to fade due to the challenges of globalization, technological advances, and the influence of foreign ideologies. The problem faced by students at the UPMI in Medan is that their understanding of Pancasila is limited to memorization without appreciation and practice in their daily lives. The phenomena of intolerance, individualistic attitudes, and a decline in social awareness indicate that the internalization of Pancasila values has not been successful. To overcome these problems, activities to promote the Pancasila Virtue Movement were carried out in coordination with the UPMI rectorate and student organizations. I. INTRODUCTION

Based on these conditions, it is very important to socialize the Strengthening of the Pancasila Virtue Movement to UPMI Medan students.

This activity aims to increase students' understanding of the meaning and implementation of Pancasila values in everyday life, as well as encourage students to participate in the Pancasila Virtue Movement through concrete actions. Through this community service activity, it is hoped that students will understand that Pancasila is not just a theory learned in class, but a guide for life that must be practiced. This socialization was carried out using interactive and engaging methods, employing an approach relevant to students' lives, and providing concrete examples of how Pancasila values can be applied in campus life and society, so that students not only understand but are also motivated to become pioneers of the Pancasila Virtue Movement in their communities.

II. COMMUNITY SERVICE IMPLEMENTATION METHOD

This community service program began with a preparation phase involving coordination with the Indonesian Community Development University (UPMI) in Medan, particularly with the student affairs unit and student organizations active on campus. Through discussions and mutual agreement with the relevant parties, it was decided that the socialization of the Strengthening of the Pancasila Virtue Movement would be carried out on the UPMI Medan campus in North Sumatra, involving students from various study programs and semesters. The implementation of the activity followed a series of systematically planned stages, namely:

a. Coordination and Preparation Stage

This activity began with an in-depth coordination stage between the community service team and the UPMI rectorate, the student affairs department, and student organizations to develop an effective implementation strategy in line with student needs. The team identified issues related to the understanding and practice of Pancasila values among students through observation and brief interviews with several students and student affairs advisors. At this stage, the team also prepared interesting and relevant socialization materials related to student life, including an introduction to the Pancasila Virtue Movement, the implementation of Pancasila values in campus and community life, and examples of virtuous actions that students can take. The team also prepared supporting media in the form of visual presentations, inspirational videos, and guidance modules to be distributed to participants.

b. Socialization Implementation Stage

During the implementation stage, the activity began with remarks from representatives of the UPMI rectorate, the head of community service, and student representatives. The team delivered the main material, which covered the history and meaning of Pancasila as the foundation of the state, the urgency of strengthening Pancasila values in the modern era, an introduction to the Pancasila Virtue Movement along with its objectives and benefits, the implementation of each principle of Pancasila in students' daily lives, and strategies for becoming agents of change in spreading virtue on campus and in the community. The material was delivered using interactive lectures, group discussions, inspirational videos about young figures who practice Pancasila values, and question and answer sessions that gave students the opportunity to share their experiences and ask questions about the application of Pancasila values.

c. Evaluation and Follow-up Stage

The evaluation stage was conducted to measure the students' level of understanding and enthusiasm for the material presented. The evaluation was carried out through a questionnaire filled out by participants, which contained questions about their understanding of the material, the benefits of the activity, and their commitment to practicing the Pancasila Virtue Movement. The team also held discussions with student representatives to formulate concrete action plans that could be carried out as

a follow-up to this outreach activity. The action plans included the formation of a community or group of students concerned with Pancasila, the development of regular virtue programs on campus, and campaigns promoting Pancasila values through student social media.

The results of the activity are as follows:

1. III. COMMUNITY SERVICE IMPLEMENTATION MATERIALS

Students can demonstrate social awareness by actively participating in community service activities, helping people in need, sharing knowledge by providing free tutoring to underprivileged children, or developing community empowerment programs.
